- I will not include methods or techniques in the classes I teach, which are not covered in the syllabus and manuals of the courses developed by Academy of Healing Arts or TFH.

 - Touch for Health class list to NZITFHK using the TFH class list form and will email TFH certificates provided to all attending students including repeat students.

Ethical Behaviour and Codes of Practice
